- Informal carer: an Informal Carer is a relative or other responsible adult with whom the child lives, and who has day to day care of the child. The informal carer should provide an Informal Carer Statutory Declaration to confirm their status as an informal carer. - Students living independently: If the student is an adult or a mature minor for the purpose of enrolment and they live
 independently. These students will need to be considered in accordance with the <u>www.education.vic.gov.au/pal/decisionmaking-responsibilities-students/policy</u> policy.
- Adult Students: a student 18 years of age or older is considered an adult and can sign their own consent form.
